TIE FOR CORNER NEAR THE CENTER OF COUNTY ROAD 4516 AND THE APPARENT WEST LINE OF FIRST TRACT AS DESCRIBED IN DEED TO LONNIE AND CHRISTINA HAIRGROVE ET AL, RECORDED IN VOLUME 1992, PAGE 989, OFFICIAL PUBLIC RECORDS, HENDERSON COUNTY, TEXAS, SAID POINT BEING THE RECOGNIZED MOST SOUTHERLY NORTHEAST CORNER OF SAID RUNAWAY RANCHES TRACT AND THE APPARENT SOUTHEAST CORNER OF A TRACT OF LAND DESCRIBED IN DEED TO CHARLES W. AND BARBARA A. SCHMIDT, RECORDED IN DOCUMENT NO. 2013-00016082, OFFICIAL PUBLIC RECORDS, HENDERSON COUNTY, TEXAS, FROM WHICH A 1/2 INCH IRON ROD FOUND FOR WITNESS BEARS NORTH 89 DEGREES 35 MINUTES 47 SECONDS WEST -

THENCE SOUTH 07 DEGREES 38 MINUTES 23 SECONDS EAST, WITHIN SAID COUNTY ROAD 4516, ALONG THE RECOGNIZED EAST LINE OF SAID RUNAWAY RANCHES TRACT AND THE APPARENT WEST LINE OF SAID HAIRGROVE FIRST TRACT (VOL. 1992, PG. 989), A DISTANCE OF 419.23 FEET TO A POINT FOR CORNER, SAID POINT BEING THE SOUTHWEST CORNER OF HEREIN DESCRIBED TRACT, FROM WHICH A 1/2 INCH IRON ROD SET WITH YELLOW CAP STAMPED BG&A RPLS 5569 FOR WITNESS BEARS SOUTH 89 DEGREES 37 MINUTES 03 SECONDS WEST - 23.47 FEET AND THE RECOGNIZED SOUTHWEST CORNER OF SAID RUNAWAY TRACT BEARS SOUTH 07 DEGREES 38 MINUTES 23 SECONDS EAST - 100.81 FEET;


